### 2. COMPOSITION / INFORMATION ON INGREDIENTS

**Contains:** No ingredients classified as hazardous.

### 3. HAZARDS IDENTIFICATION

**Main hazards:** No significant hazard.

### 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** No significant effect. Prolonged or repeated contact may defat the skin leading to dermatitis.

**Eye contact:** May cause temporary discomfort.

**Ingestion:** Nausea and stomach pain may occur. There may be vomiting and diarrhoea.

**Inhalation:** Low volatility makes inhalation unlikely at ambient temperatures.

**Inhalation:** If affected, remove to fresh air. Seek medical attention.

### 5. FIRE-FIGHTING MEASURES

**Extinguishing media:** Carbon dioxide. Dry chemical powder. Alcohol or polymer foam.

**Exposure hazards:** Toxic or irritating fumes may be released at elevated temperatures.

**Protection of fire-fighters:** Wear protective clothing to prevent contact with skin and eyes.

### 6. ACCIDENTAL RELEASE MEASURES

**Personal precautions:** Eliminate all sources of ignition. Wear appropriate protective clothing.

**Environmental precautions:** Do not discharge into drains or rivers. Contain the spillage using sufficient appropriate absorbent material.

**Storage conditions:** Store between 0 and 35 Deg.C. Keep container tightly closed.
