### 2. COMPOSITION / INFORMATION ON INGREDIENTS

**Hazardous ingredients:** PROPAN-2-OL <1%  
EINECS: 200-661-7 CAS: 67-63-0

- FATTY ALCOHOL ETHOXYLATE <1%

**Contains:** Lemon perfume.

### 3. HAZARDS IDENTIFICATION

**Main hazards:** No significant hazard.

**Other hazards:** This product is not classified as hazardous under current legislation.

### 4. FIRST AID MEASURES (SYMPTOMS)

**Skin contact:** There may be irritation and redness at the site of contact.

**Eye contact:** There may be irritation and redness. The eyes may water profusely.

**Ingestion:** There may be soreness and redness of the mouth and throat. There may be difficulty swallowing. Nausea and stomach pain may occur. There may be vomiting.

**Inhalation:** There may be irritation of the throat with a feeling of tightness in the chest.

### 4. FIRST AID MEASURES (ACTION)

**Skin contact:** Remove all contaminated clothes and footwear immediately unless stuck to skin. Drench the affected skin with running water for 10 minutes or longer if substance is still on skin. Seek medical advice if irritation develops.

**Eye contact:** Bathe the eye with running water for 15 minutes. Transfer to hospital for specialist examination.

**Ingestion:** Do not induce vomiting. If conscious, give half a litre of water to drink immediately. Seek medical attention.

**Inhalation:** Remove casualty from exposure ensuring one's own safety whilst doing so. If unconscious, check for breathing and apply artificial respiration if necessary. If unconscious and breathing is OK, place in the recovery position. If conscious, ensure the casualty sits or lies down. If breathing becomes bubbly, have the casualty sit and provide oxygen if available. Transfer to hospital as soon as possible.

**5. FIRE-FIGHTING MEASURES**

**Extinguishing media:** The product is non-combustible; appropriate extinguishing media for surrounding area should be used in fire situations.

**Exposure hazards:** Hydrogen chloride fumes may be released.

**Protection of fire-fighters:** Wear self-contained breathing apparatus. Wear protective clothing to prevent contact with skin and eyes.

**6. ACCIDENTAL RELEASE MEASURES**

**Personal precautions:** Mark out the contaminated area with signs and prevent access to unauthorised personnel. Turn leaking containers leak-side up to prevent the escape of liquid.

**Environmental precautions:** Do not discharge into drains or rivers. Contain the spillage using sufficient appropriate absorbent material.

**Clean-up procedures:** Transfer to a closable, labelled salvage container for disposal by an appropriate method. Wash the spillage site with large amounts of water.

**7. HANDLING AND STORAGE**

**Handling requirements:** Ensure there is sufficient ventilation of the area. Avoid direct contact with the substance.

**Storage conditions:** Store in cool, well ventilated area. Keep container tightly closed.

**8. EXPOSURE CONTROLS / PERSONAL PROTECTION**

**Hazardous ingredients:** PROPAN-2-OL  
WEL (8 hr exposure limit): 999 mg/m<sup>3</sup> WEL (15 min exposure limit): 1250 mg/m<sup>3</sup>

**Engineering measures:** Ensure there is sufficient ventilation of the area. Hydrochloric acid OEL: 8h TWA = 1ppm; 15min STEL = 5ppm (hydrogen chloride)

**Respiratory protection:** If Workplace Exposure Limit(s) listed above are exceeded, respiratory protection may be required.

**Hand protection:** Protective gloves.

**Eye protection:** Safety goggles.

**Skin protection:** Protective clothing with elasticated cuffs and closed neck. Boots made of PVC.
