1. IDENTIFICATION OF THE SUBSTANCE / PREPARATION AND OF THE COMPANY / UNDERTAKING

Product name: SCRUBS

Use / description of product: Superior heavy duty hand wipes.

2. COMPOSITION / INFORMATION ON INGREDIENTS

Contains: Liquid hand cleaner absorbed onto abrasive towel.

3. HAZARDS IDENTIFICATION

Main hazards: No significant hazard.

4. FIRST AID MEASURES (SYMPTOMS)

Skin contact: Product is designed for use on skin, however it should not be used on skin that is broken or inflamed as irritation can arise.
