**Hazardous ingredients:** FATTY ALCOHOL ETHOXYLATE 1-10%

### 3. HAZARDS IDENTIFICATION

**Main hazards:** No significant hazard.

### 4. FIRST AID MEASURES (SYMPTOMS)
